#### **About Organisation**

People's Action for Rural Advancement & Sustainability — (PARAS Foundation )was founded in year 2005 in society act by local social worker of PANI Sansthan in village-Jai Prabha Gram (Bhawaniyapur) Post- Pirkhauli Faizabad .The organization presently has a significant presence in Faizabad districts of Eastern Uttar Pradesh.

PARAS Foundation is covering work of various social, economic, political and cultural aspects of society.

PARAS Foundation is also developing capacity building of community. The organization also effectively working with rural women, marginal farmers, landless family, children and teenage girls in integrated approach of development . PARAS strengthening capacities of people so that they are able to understand their own situations, recognize their challenges and face them.

Our thematic area is Natural Resource Management, Gender governance, Health and Nutrition, Climate Change, Sustainable Livelihoods, and Integrated Child Development.

#### **Main Aim and Objects of Association**

Ayodhya district is known for its historical and religious significance, while Barabanki district is primarily an agricultural region. The PARAS Foundation likely operates in these areas to carry out various social welfare and developmental.

#### **Major ongoing project:**

**Vaccination:** The PARAS Foundation is completed a vaccination project. It aims to facilitate and promote vaccination efforts for save people's from Covid-19, likely in the targeted geographical area of Puredalai block in Barabanki district. This project is supported by the Azim Premji Foundation.

**ERW** (Empowering Rural Women): PARAS Foundation is also involved in an initiative called "Empowering Rural Women." This project likely aims to empower and uplift women living in rural areas, providing them with opportunities for education, skill development, and socio-economic empowerment and welfare schemes entitlement realization. The ERW project is also supported by the Azim Premji Foundation.

Strengthening Civil Society Organizations Towards Fostering Women Empowerment in Eastern Uttar Pradesh: This project, funded by The European Union and supported by ChildFund India, focuses on strengthening civil society organizations in Eastern Uttar Pradesh. The objective is to foster women's empowerment in the region, likely through, entrepreneur, climate friendly agricultural practises, linkages with Governmental schemes' related agriculture, capacity building, advocacy, and support for initiatives promoting gender equality and women's rights.

#### Outcome of the year

The PARAS Foundation has achieved significant outcomes in its projects over the year. We successfully completed a vaccination project in the Puredalai block of Barabanki district, aiming to facilitate and promote COVID-19 vaccination efforts. The project contributed to increased vaccination coverage, ensuring more people were protected from the virus. "Empowering Rural Women" focused on development of women in rural areas. Through this project, women were provided with opportunities for raise voice against domestic violence, realization of entitlement service, capacity building, and socio-economic empowerment. We have completed strengthen civil society organizations in Eastern Uttar Pradesh project. The objective was to foster women's empowerment in the region through various means such as entrepreneurship, climate-friendly agricultural practices, linkages with governmental agricultural schemes, capacity building, advocacy, and support for initiatives promoting gender equality and women's rights. "Additionally, in collaboration with the community, the PARAS Foundation operates a school from nursery to class 10 in the Sohawal block. Through this initiative, they are able to provide quality education to the rural areas, ensuring that children in these communities have access to educational opportunities." This highlights the PARAS Foundation's dedication to

providing education and bridging the educational gap in rural areas by operating a school that offers quality education to students from nursery to class 10<sup>th</sup> in the Sohawal block. These outcomes reflect the foundation's dedication to addressing vital issues such as public health, Education, women's empowerment, and community development. Through their projects, the PARAS Foundation has made a positive impact on society by saving lives through vaccinations, empowering rural women, and promoting gender equality in Eastern Uttar Pradesh.

### Climate informed agriculture, entrepreneurship and Promotion of agro based livelihood through women famers.

Climate-informed agriculture and entrepreneurship have made a significant impact on promoting agro-based livelihoods, particularly among women farmers. As a result, 97 families have successfully adopted multi-layer vegetable production, leading to improved agricultural output. Additionally, 1031 families have experienced a substantial increase in their average income by Rs. 2619 through altered cropping seasons. The implementation of rice intensification techniques has resulted in 103.5 acres of land being efficiently utilized. Furthermore, 418 farmer families are now utilizing compost, while 230 have adopted green manuring, enhancing soil fertility and sustainability. The benefits of agricultural schemes have reached 119 farmer families, and an additional 186 families have started intercropping systems to generate extra income. Moreover, 144 flood-affected farmer families have received paddy for the third time, aiding their recovery efforts. A significant achievement has been made in reducing crop burning, with 1308 farmers eliminating this practice across their 795 -acre farmland by adopting sugarcane mulching techniques using leaves. Finally, these efforts have collectively conserved a remarkable 2.53 million cubic meters of water in agriculture through various water-saving techniques.

#### Women socio economic right & Empowerment



PARAS Foundation has made significant progress in its ERW project, benefitting 2473 women across 10 Gram Panchayats in Rudauli Block, Ayodhya district. The project aimed to enhance the functioning of local governance (PRI) to reduce domestic violence, increase women's participation in open Gram Sabha meetings, ensure the regular operation of PDS shops, facilitate entitlement realization for welfare schemes, improve healthcare services, and promote the MNREGA scheme in villages. Key achievements include the issuance of 49 women job cards in MNREGA, the successful resolution of 6 domestic violence cases, the active involvement of 11 Nari Sangh leaders in monitoring MDM and PDS schemes, a 20% increase in women's

participation in open Gram Sabha meetings, the regular participation of 41 Nari Sangh leaders in VHND for quality assurance, 756 women submitting written demand letters to Pradhan's for work in MNREGA, the participation of an MLA in Nari Sangh's events and meetings, and the consistent organization of Nari Sangh meetings. These accomplishments demonstrate PARAS Foundation's commitment to empowering women and promoting effective local governance.

#### Facilitation to women child health.

Our organization has been actively involved in facilitating women and child health, with a particular focus on maternal health for women aged 15 to 49. Our efforts have been directed towards several key areas, including early registration of pregnancies, ensuring three complete Antenatal Care (ANC) visits, identifying and referring high-risk pregnancies, promoting birth preparedness and spacing, facilitating safe deliveries, providing Postnatal Care (PNC), and tracking maternal deaths. Additionally, we have worked towards increasing access to the Janani Suraksha Yojana (JSY) scheme benefits. The results of our endeavors have been highly encouraging, as we have achieved 100% registration of pregnancies in Anganwadi Centers (AWCs), with 99% of pregnant women participating in complete ANC visits. Furthermore, we have successfully identified and referred six high-risk cases, leading to appropriate care. A remarkable 97% of deliveries have taken place in hospitals, ensuring safer birthing conditions. Finally, 213 women have received the JSY scheme benefits, further enhancing maternal and child health outcomes in our target communities.

#### Maternal, Neonatal, Child Health

In the domain of Maternal, Neonatal, and Child Health, our organization has been actively engaged in providing comprehensive support to the community. For children aged 0 to 6 years, our efforts have focused on ensuring complete immunization, monitoring growth, de-worming, and referring severely underweight children for appropriate care. We have also promoted immediate and exclusive breastfeeding, as well as supplementary nutrition, while effectively managing diarrhea and pneumonia cases. Moreover, we have prioritized the management of low birth weight (LBW) babies and implemented a robust system for tracking under-5 deaths. As a result, we have achieved a commendable 90% completion rate for immunization within the designated time schedule. Additionally, 228 kits have been distributed by our health workers for deworming, and nine children have been referred for underweight conditions. Furthermore, our health workers have identified and referred 24 cases of diarrhea to hospitals, ensuring timely treatment.

In the realm of Adolescent Health, specifically targeting individuals aged 15 to 19 years, we have implemented various initiatives. These include tracking and addressing cases of anaemia, providing iron and folic acid (IFA) supplements and de-worming treatments, promoting menstrual hygiene practices, and advocating for delayed age of marriage. Notably, our health workers have identified and provided iron tablets to 94 adolescents suffering from anaemia. Additionally, 630 kits have been distributed for de-worming purposes, benefiting a significant number of adolescents. Moreover, 328 adolescents actively participated in hygiene meetings, enhancing their knowledge and practices in this area. Importantly, no cases of underage marriage have been identified within our target population. These accomplishments underscore our commitment to promoting the health and well-being of mothers, neonates, children, and adolescents in the communities we serve.

#### Realization of entitlements services

Our organization has successfully collaborated with various government schemes to promote sustainable agriculture and enhance farming practices. As part of this collaboration, we have conducted soil testing for 630 samples, enabling farmers to make informed decisions regarding soil nutrient management. Additionally, we have mobilized subsidized hybrid paddy seeds weighing 61 kg and subsidized wheat seeds weighing 1480 kg, provided by the agriculture department, to support farmers in adopting improved seed varieties. In association with the horticulture department, we have established two permanent pit vermi composting units,

facilitating organic waste management and enhancing soil fertility. Furthermore, we have distributed seeds of bottle gourd (1.5 kg), bitter gourd (1.75 kg), and garlic (180 kg) from the horticulture department, promoting diversification and increasing income opportunities for farmers. The agriculture department has also supported our efforts by providing five solar pumps, enhancing access to irrigation for farmers, and installing four drip systems and one sprinkler system from the horticulture department, ensuring efficient water management. We have also received 44 vegetable carry trays from the horticulture department, facilitating the safe transportation of produce. Additionally, we have been entrusted with 480 decomposer kits by the agriculture department, enabling farmers to adopt sustainable waste management practices. Lastly, we have conducted five batches of agriculture training sessions for farmers, introducing them to innovative agricultural techniques and empowering them with valuable knowledge. These collaborations with government schemes have significantly contributed to the advancement of agriculture and the well-being of farmers in our target areas.

#### **Environmental health:**

Our organization has been actively promoting environmental health through various initiatives. To promote self-sufficiency and nutrition, we have successfully established kitchen gardens for 730 families, enabling them to grow fresh vegetables and herbs. Ensuring the safety of drinking water sources is another priority, and we have collaborated with the community to clean and maintain 91 water sources, providing access to clean and safe drinking water. Recognizing the importance of preserving our ecosystem, we have conducted extensive tree plantation drives in collaboration with the forest department, resulting in the planting of 14,000 trees. Additionally, we have focused on effective garbage management by encouraging 148 families to prepare shock pits for proper waste disposal and water management. Furthermore, our efforts to reduce farm burning have been successful, as we have prevented 1,830 farmers from engaging in this harmful practice, thereby mitigating air pollution. Lastly, we have emphasized the importance of improving soil health through sustainable agricultural practices, benefiting numerous farmers in our target areas. These results demonstrate our commitment to promoting environmental health and sustainability..

#### Better education better life!

Under our initiative "Better Education, Better Life!" PARAS Foundation is operating a school catering to children aged 3 to 16 years. Our school offers classes ranging from nursery to 10th class, serving a total of 155 students. This year, we are proud to report that we have admitted 66 new students from nearby villages, expanding our reach and impact.

We are committed to providing education to children from all backgrounds, and as part of this commitment; we offer both free and fee-based education options. Moreover, we understand the challenges faced by children in rural areas when it comes to transportation. To address this, we provide free transportation services to 55 students, ensuring they have convenient access to our school.

Our curriculum encompasses essential subjects such as English, Hindi, Math, and Computer Education. We emphasize delivering quality education to rural areas, and to achieve this, we have recruited well-educated and experienced teachers who are dedicated to the students' holistic development.

We are grateful for the support we have received from partners like the LIC Golden Jubilee Foundation. Their generous contribution has allowed us to acquire a 16-seater Mahindra Bus, which has further enhanced our transportation capabilities, enabling more students to attend school comfortably and safely.

Through our "Better Education, Better Life!" initiative, we remain committed to providing quality education, fostering a love for learning, and empowering children with the knowledge and skills they need for a brighter future.

#### **Capacity building of community**

As part of our commitment to community development, PARAS Foundation has been actively engaged in capacity building initiatives. We have organized several training programs aimed at empowering farmers, Nari Sangh leaders, women, and adolescent girls.

For farmers, we conducted 380 training sessions to enhance their capacity and encourage the adoption of improved agricultural techniques. These training sessions focused on water-saving agriculture practices, water resource management, tree plantation, and market assessment. A total of 7,660 farmers participated in these training programs, with 1,019 farmers successfully adopting the techniques taught. It is noteworthy that 5,535 women actively participated in these training sessions, highlighting our efforts to promote gender-inclusive capacity building in the agricultural sector.

To strengthen the leadership and management skills of Nari Sangh leaders, we organized two training sessions, with 120 leaders participating. The training covered topics such as group management, record-keeping, and leadership skill development. As a result, two Nari Sangh groups have successfully initiated their operations and implemented record-keeping practices.

We also conducted five training programs for rural women under the Nari Sangh initiative. These training sessions focused on their rights, leadership development, Nari Sangh management, and various government schemes. A total of 125 Nari Sangh members participated in these training sessions, equipping them with knowledge and skills to advocate for their entitlements, such as the right to work, right to food, and right to health. These empowered women have raised their voices in Gram Sabhas, catalyzing the realization of their entitlements.

Furthermore, we have been dedicated to the development of adolescent girls. We organized regular weekly training sessions for 52 girls, focusing on vocational skill development, safety, and hygiene. All 52 girls successfully learned beautician skills, enhancing their prospects for self-employment and economic independence.

Through these capacity building initiatives, PARAS Foundation remains committed to empowering individuals and communities, enabling them to lead more sustainable, prosperous, and fulfilled lives.

#### **Extension of People's institution**

PARAS Foundation firmly believes in the extension of people's institutions as an essential component of our sustainable development efforts. We recognize that true empowerment comes when individuals possess the necessary skills, confidence, and control over resources to manage their own institutions and find innovative ways to progress.

One of the key people's CBOs we have established is Nari Sanghs. These collectives of women operate at the village, and block levels, providing a platform for women to come together, advocate for their rights, and claim their entitlements. Nari Sanghs empower women to voice their concerns, participate in decision-making processes, and work towards achieving gender equality and social justice. These CBOs play a pivotal role in fostering community solidarity and creating an enabling environment for women's empowerment.

In addition, we have established Farmer Resource Centres and Farmers producer organization (FPO), which serve as vital hubs for farmers at the village level. These centres provide farmers with access to appropriate agricultural inputs, technologies, and knowledge for sustainable farming practices. By offering resources such as improved seeds, organic fertilizers, and efficient irrigation techniques, the Farmer Resource Centres enable

farmers to enhance their productivity, optimize resource utilization, and adopt environmentally friendly agricultural methods. These centres also serve as platforms for knowledge sharing, capacity building, and fostering collaboration among farmers in the community.

By extending people's CBOs like Nari Sanghs and Farmer Resource Centres, PARAS Foundation aims to create sustainable structures that ensure the long-term success of our development initiatives. We believe that empowering individuals and communities with the skills, resources, and ownership of these COBs will lead to self-empowerment, resilience, and the ability to forge new pathways towards progress and prosperity.

#### **Accountability and Transparency**

At PARAS Foundation, we prioritize accountability and transparency in all our financial operations. 
